



GLOBAL HARMONIZED SYSTEM OF CLASSIFICATION AND LABELLING OF CHEMICALS

GHS is a system for standardizing and harmonizing the classification and labelling of chemicals. It is a logical and comprehensive approach to: (1) Defining health, physical and environmental hazards of chemical; (2) Creating classification processes that use available data on chemicals for comparison with the defined hazard criteria; and (3) Communicating hazard information, as well as protective measures, on labels and Safety Data Sheets (SDS).

The new required labeling system by OSHA is quite simple. There are "primary labels" and "secondary labels". If a chemical is moved from it's original container to a secondary container (such as a beaker, plastic jug, or spray bottle) then it requires a secondary label of some sort.

- * PRODUCT IDENTIFIER * SIGNAL WORD * HAZARD STATEMENT * PICTOGRAMS
- * PRECAUTIONARY STATEMENTS * MANUFACTURER NAME - ADDRESS - PHONE


